### ***MEMBERSHIP CONDITIONS***

- All subscriptions, for all categories of membership, must be paid in full by the 31st of January 2024.
- Individuals who fail to pay by the 31st of January 2024 will cease to become a member and will no longer be able to purchase Green Fees at the discounted rate.

The Membership Renewal Fees are as follows:

- Annual €1350
- Family (only available to existing family memberships) €2700
- Intermediate (only available to existing student members that are no longer classed as students) €500
- Student €300
- Junior €200
- Any member who wishes to apply for a Premium Credit payment plan, please contact our office at Galway Bay Golf Resort.
- Premium credit applications will be accepted up to and including the 24th of January 2024. Premium Credit will no longer be available after this date.
- Terms and Conditions must be agreed and signed (through our website link) along with membership payment at the time of application/renewal in order to receive your membership pack.
